COMPLETING A NON-PRODUCER STATUS FORM

This form allows dealers and order buyers to carry out their business without having to pay additional checkoff dollars on cattle re-sold within 10 days of purchase. It is for the dealer to use; not the producer/farmer. The form should go with the cattle when you re-sell them.

For auditing purposes this book and the document numbers inside have been assigned to you. Do not allow anyone to use documents assigned to you.

- 1. Number: This is the number of cattle being re-sold. This form can be used for any number of cattle which are being re-sold as a group.
- 2. Date: This is the actual date the cattle are re-sold.
- 3. Buyer: This is the person or entity (livestock market, packing house, ect.) buying the cattle from you.
- 4. Re-seller: This is you, the person re-selling cattle you purchased within 10 days of this transaction. This form must be properly and legibly completed and signed to be valid. Any document received by us that is not completed correctly may be returned to the sender with a request that it either be completed correctly or the sender will be required to submit the \$1 per head that would otherwise be due on these cattle.
- 5. Date: This is the actual date the cattle were purchased.
- 6. Re-seller Certification: This is the reason you are claiming non-producer status.
 - a. You have collected a dollar and will remit it. Or
 - b. You received a certificate of non-producer status form from the person from whom you purchased the cattle. Or
 - c. You purchased the cattle in a transaction in which the checkoff was collected by a livestock market or brand inspector.
