Sales: \$282.1 million

Jobs: 2,446

Value-Added: \$165.4 million

Labor Income: \$91.9 million

Inputs: \$116.7 million

Taxes: \$25.7 million

Sales: The broadest measure of economic activity - often referred to as "output"; **Employment (Jobs):** A measure of job positions without regard to whether they are full-time equivalents; **Value-Added:** Sales (output) minus the cost of inputs; **Taxes:** Includes taxes paid at the federal, state and local levels.

Overall Contributions to Laclede County

Agricultural, forestry, and related industries support 2,446 jobs in Laclede County. Additionally, these industries contribute \$282.1 million in sales, which translates to \$165.4 million in added value to the area after \$116.7 million worth of inputs are purchased. Of this \$165.4 million, \$91.9 million is comprised of labor income. Tax revenues generated by the agricultural, forestry, and related industries in Laclede County are \$25.7 million.
