

# MISSOURI DEPARTMENT OF AGRICULTURE (MDA) TECHNICIAN TRAINING PROGRAM OUTLINE CATEGORY 7B – TERMITE PEST CONTROL

"MDA-7B" = Approval Code

"MDA-7B" is a Missouri approved Pesticide Technician Training program for Category 7B, Termite Pest Control.

- 1. "MDA-7B" APPROVED CLASSROOM TRAINING (8 hours minimum) will consist of reading and studying the current versions of the following materials:
  - A. The National Pesticide Applicator Certification Core Manual;
  - B. The Category 7B Wood-Destroying Pest Management Manual; and
  - C. The Missouri Pesticide Use Act (Chapter 281 RSMo and regulations).

The above outlined training meets the following minimum times established for each classroom topic: 1.5 hours of Pest Identification, 1 hour of Equipment, 1.5 hours of Pesticides, 30 minutes of Alternative Control Methods, 1 hour of Labels, 1 hour of Pesticide Hazards and Safety, 30 minutes of Pesticide Spills, and 1 hour of Pesticide Laws. At a minimum, list these times per classroom topic on the **Pesticide Technician Notice of Training** form.

- **2.** "MDA-7B" APPROVED ON-THE-JOB (OTJ) TRAINING (16 hours minimum) must meet the following criteria:
  - A. The OTJ practical training must cover each topic in the following "MDA-7B" ON-THE-JOB TRAINING OUTLINE. The suggested times, at a minimum, must be used; and
  - B. The OTJ practical training must be done in the physical presence of a Certified Commercial Applicator licensed in Category 7B.
- **3.** "MDA-7B" classroom and OTJ training is to be verified on a **Pesticide Technician Notice of Training** form. #### 4. "MDA-7B" ON-THE-JOB TRAINING OUTLINE:

#### A. PEST IDENTIFICATION: (suggested time 1 hour)

Trainees shall acquire and demonstrate the ability to identify pests commonly found in termite (and other wood destroying organisms) pest control. This topic includes the identification of potential harborages, damage caused by, and conditions which favor the existence of termites and other wood destroying organisms.

## B. EQUIPMENT: (suggested time 10 hours)

Trainees shall acquire and demonstrate the ability to use, maintain, and calibrate equipment commonly used in the control of termites and other wood destroying organisms.

### C. PESTICIDES: (suggested time 2 hours)

Trainees shall acquire and demonstrate the ability to properly use, mix, handle, store, and dispose of pesticides commonly used to control termites and other wood destroying organisms.

### D. ALTERNATIVE CONTROL METHODS: (suggested time 1 hour)

Trainees shall acquire and demonstrate the ability to use common non-chemical methods of control for termites and other wood destroying organisms, including Integrated Pest Management practices.

### E. PESTICIDE HAZARDS AND SAFETY: (suggested time 1 hour)

Trainees shall acquire and demonstrate the ability to use personal protective equipment, proper waste and container disposal methods, and safety procedures that minimize non-target contamination.

#### F. PESTICIDE SPILLS: (suggested time 1 hour)

Trainees shall acquire and demonstrate the ability to control, report, and clean up pesticide spills. This shall include: the use of personal protective equipment during cleanup; containment practices and chemical absorption materials; and procedures used to reduce the possibility of pesticide spills.
