**Please describe the methods your agency considered or used to reduce the impact on small businesses:** State Milk Board has a regulatory responsibility, as a National Conference on Interstate Milk Shipments (NCIMS) participant, to maintain uniformity of standards contained in the Grade "A" Pasteurized Milk Ordinance (PMO) — 2017 Revision of the United States Department of Health and Human Services, Public Health Service, Food and Drug Administration document. The adoption of the 2017 edition of this publication into code of state regulation fulfills State Milk Board obligations as milk regulatory authority for State of Missouri under cooperative agreement between U.S. Department of Health and Human Services Public Health Service, FDA, and NCIMS. This is an administrative action with no new obligations for small milk production, processing, or laboratory businesses.
